Organizational Setting

The Plant Production and Protection Division (AGP) promotes the sustainable intensification of crop production (SCPI). This requires the integration and harmonization of all appropriate crop production policies and practices within the broader framework of sustainable food and agriculture that aims at enhancing productivity; natural resources conservation; rural livelihoods and resilience.

The post is located in the Ecosystem Management Team (AGPME) one of the six teams in the Division. AGPME provides advice, technical support and guidance to countries aimed at maintaining and enhancing ecosystem services as essential components of sustainable and integrated agricultural production systems. The incumbent is part of a Team of technical specialists that includes expertise on sustainable agriculture, cropping systems, plant nutrition, soil health, ecosystem services and various aspects of agrobiodiversity. In cooperation with staff within and outside the Division, particularly on animal production, aquaculture and agroforestry, the incumbent contributes to a programme of work on SCPI that emphasizes the use of agroecological approaches and practices that contribute to sustainable agricultural production systems with a particular focus on smallholder farmers.
