DUTIES AND RESPONSIBILITIES

Under the overall supervision of the Executive Secretary and the day-to-day technical guidance of the head of the Data Section of IOTC, the incumbent will provide technical support in establishing and maintaining statistical systems for collecting data on tuna and tuna-like species in countries in the Indian Ocean. In particular, the incumbent will:

- Participate in the collation, verification and input of fisheries data in the IOTC database;
- Estimate missing data sets using appropriate statistical procedures;
- Participate in the development of computerized procedures to maintain the IOTC databases and in the preparation of data sets;
- Maintain appropriate up-to-date documentation of the databases and associated procedures;
- Participate in the design of data collection and management activities in IOTC participating countries.
- Participate in the implementation of data collection and management activities in IOTC participating countries;
- Prepare training material required for the implementation of data collection and management activities, including sampling and data entry
 manuals, and undertake training of local staff on sampling, data entry and processing.
- Undertake missions to sampling sites in order to ensure the accurate execution of data collection and other related activities.
- Monitor the reporting, validation and verification of data generated from sampling programmes; document and report procedures developed to
 process the information obtained through data collection activities.
- Prepare progress reports on data collection activities for presentation to meetings of the Commission and its subsidiary bodies.
- Perform other related duties as required.

MINIMUM REQUIREMENTS

- · University Degree in Fisheries, Biological Science or Statistics
- Five years of relevant experience in the field of fisheries statistics, including field experience

- Extent of supervisory skills
- Depth of knowledge of tuna fisheries
