Organizational Setting

The Regional Office for Latin America and the Caribbean (RLC) is responsible for leading FAO's response to regional priorities for food security, agriculture and rural development through the identification, planning and implementation of FAO's priority activities in the region. It ensures a multidisciplinary approach to programmes, identifies priority areas of action for the Organization in the Region and, in collaboration with departments and divisions at Headquarters, develops, promotes and oversees FAO's strategic response to regional priorities. FAO RLC also advises on the incorporation of regional priorities into the Organization's Programme of Work and Budget and implements approved programmes and projects in the region, monitors the level of programme implementation and draws attention to problems and deficiencies. FAO RLC develops and maintains relations with region-wide institutions including the Regional Economic Integration Organizations (REIOs).

The Regional Office supports regional policy dialogue on food security, agriculture and rural development issues, facilitates the emergence of regional partnerships, and supports capacity development and resource mobilization for food security, agriculture and rural development in the region.

The post is located in the Regional office for the Latin America and the Caribbean in Santiago, Chile.

Reporting Lines

The Land Tenure and Natural Resources Officer reports to the Officer responsible for increasing productivity and enhancing sustainability of agriculture forestry and fishery sectors. The Land Tenure and Natural Resources Officer contributes to one or more teams to reduce rural poverty, enhance sustainability of production and increase the resilience of livelihoods to threats and crises in Latin America and the Caribbean in dialogue and coordination with subregional offices..

- Provide regional perspective and priorities in support to FAO's periodic planning and programming exercises and the
 development of FAO's strategic framework, and contribute to the implementation of the Regular Programme in the field of
 responsible governance of land and natural resources tenure
- Support country-level actions guided by FAO's Country Programming Frameworks (CPFs), subregional and regional
 priority frameworks, regional initiatives and higher-level strategic frameworks of the Organization in order to transform
 FAO's knowledge products into country-level results and impacts;
- Contribute to FAO's multidisciplinary teams in the development of an integrated and coherent approach to land and natural
 resources tenure, drawing on the corporate approaches and frameworks such as the Voluntary Guidelines on the
 Responsible Governance of Tenure of Land, Fisheries and Forests in the Context of National Food Security and liaises
 with relevant units in RLC, HQs and decentralized offices;
- Contribute to the analysis and understanding, and share information about policies and institutional contexts that support
 responsible governance of land and natural resources tenure, access to resources by vulnerable populations and family
 farmers in the region, including lessons learnt, and develop a data base on these policies and their impact;
- Ensure effective contributions of land and natural resources management and the responsible governance of tenure to agricultural, economic and social development policies, programmes and activities in collaboration with other agencies and donors acting in the region and at country level.
