Organizational Setting

The Forest Policy and Resources Division (FOA) leads FAO's work in promoting sustainable forest management and providing leadership on the environmental, social and economic dimensions of forestry, including its contributions to poverty reduction and food security and nutrition. FOA liaises with member countries, civil society and the private sector in aspects ranging from development of effective forest policies to forest conservation and management issues and strengthens the role of forests in climate change mitigation and adaptation. The Division also collects, analyzes and disseminates information on the world's forest resources and on the production, trade and consumption of wood and non-wood forest products.

The Division has been requested by the FAO Committee on Forests in 2016 to update the Climate Change Guidelines for Forest Policy-Makers. The Guidelines were developed in 2011 to assist countries incorporate climate considerations into their national forest programmes, forest policies and related strategies and actions. However, since the preparation of the guidelines, the international climate change dialogue has progressed substantially particularly with the advent of the Paris Agreement and the NDCs. Countries have made new commitments and through their NDCs they have articulated how they plan to achieve these. Forests have taken an increasingly prominent place the new international agreement.

Reporting Lines

The consultant will work within the Climate Change and Resilience Team under the overall guidance of the Chief, Policy and Resources, FAO Forestry Department and the technical supervision of the Forestry Officer, Climate Change and Bioenergy, and will share acquired knowledge on the current international policy discourse on forests and climate change and take the lead in the preparation of the revised guidelines in accordance with the Division's objectives and FAO Strategic Objectives.

Technical Focus

Forest policy, climate change adaptation and mitigation, sustainable development goals, national forest programmes

Tasks and responsibilities

More specifically the consultant will:

- Prepare an initial annotated outline for the revised guidelines that will constitute the starting point for the internal FAO discussions. This includes further specifying the contents as well as the scope, potential users, and objectives of the guidelines.
- Incorporate input from internal discussions and prepare revised outline.
- Develop the first draft of the (revised) guidelines (40-50 pages), in close consultation with the responsible officer and provide a print ready draft document for peer review. [Peer review will be done by experts from FAO and external partners through internal and an expert consultation.]
- Provide input to the agenda for the expert consultation, present the draft guidelines for discussion and act as facilitator during the discussions.
- Prepare (short) meeting minutes of the consultation which includes a synthesis and evaluation of the discussions and recommendations for the further development/improvement of the guidelines
- Prepare the final draft of the revised guidelines for FAO approval, incorporating the results of the expert consultation.
